North Central District Health Department regretfully is announcing two more deaths in Spencer County, one death in Shelby County, and one death in Henry County due to complications from the Novel Coronavirus (COVID-19). Fifty-seven new lab-confirmed cases in Shelby, Henry, Trimble, and Spencer Counties, increasing the district case count to 7,583. Seventy monitored by North Central District have been released from isolation.

Shelby County, KY – Spencer County has had two new COVID-19 related deaths, both elderly Caucasian males with underlying conditions; our hearts and prayers go out to their family and friends.

Shelby County has had another COVID-19 related death in an elderly Caucasian male with underlying conditions; our hearts and prayers go out to his family and friends.

Henry County has had another COVID-19 related death in an elderly Caucasian male with underlying conditions; our hearts and prayers go out to his family and friends.

North Central District Health Department has fifty-seven cases that tested positive for the Novel Coronavirus (COVID-19).

 - 5 adult Caucasian females in self-isolation at home.
 - 10 adult Caucasian males in self-isolation at home.
 - 1 elderly Caucasian male in self-isolation at home.
 - 1 elderly Caucasian male under medical care.
 - 2 pediatric Caucasian females in self-isolation at home.
 - 1 pediatric Caucasian male in self-isolation at home.
 - 6 adult Hispanic males in self-isolation at home.
 - 1 elderly Hispanic female under medical care.
 - 10 adult African American males in self-isolation at home.
 - 1 pediatric African American male in self-isolation at home.

- **Henry County= 8**
 - 3 adult Caucasian females in self-isolation at home.
 - 2 adult Caucasian males in self-isolation at home.
 - 2 elderly Caucasian females in self-isolation at home.
 - 1 adult Asian female in self-isolation at home.

- **Spencer County= 5**
 - 3 adult Caucasian females in self-isolation at home.
 - 2 adult Caucasian males in self-isolation at home.

- **Trimble County= 6**
 - 2 adult Caucasian female in self-isolation at home.
 - 3 adult Caucasian males in self-isolation at home.
 - 1 elderly Caucasian male in self-isolation at home.

North Central District released seventy individuals from isolation; fifty-seven from Shelby County, four from Spencer County, eight from Henry County and one from Trimble County monitored their symptoms and complied with a self-isolation agreement with the Health Department.
