North Central District Health Department is reporting fifty-one new lab-confirmed cases in Shelby, Henry, Trimble, and Spencer Counties, increasing the district case count to 2484. Fifty-eight individuals monitored by North Central District have been released from isolation.

Shelby County, KY –North Central District Health Department has fifty-one cases that tested positive for the Novel Coronavirus (COVID-19).

- **Shelby County = 25**
 - 7 adult Caucasian females in self-isolation at home.
 - 4 adult Caucasian males in self-isolation at home.
 - 1 elderly Caucasian female under medical care.
 - 1 pediatric Caucasian female in self-isolation at home.
 - 2 pediatric Caucasian males in self-isolation at home.
 - 2 adult Hispanic females in self-isolation at home.
 - 4 pediatric Hispanic females in self-isolation at home.
 - 3 pediatric Hispanic males in self-isolation at home.
 - 1 adult African American male in self-isolation at home.
- **Henry County= 7**
 - 3 adult Caucasian males in self-isolation at home.
 - 1 adult Caucasian female in self-isolation at home.
 - 1 pediatric Caucasian female in self-isolation at home.
 - 1 elderly African American male in self-isolation at home.
 - 1 adult African American male in self-isolation at home.
- **Spencer County= 15**
 - 8 adult Caucasian females in self-isolation at home.
 - 6 adult Caucasian males in self-isolation at home.
 - 1 pediatric Caucasian female in self-isolation at home.
- **Trimble County= 4**
 - 3 adult Caucasian female in self-isolation at home.
 - 1 adult Caucasian male in self-isolation at home.

North Central District released fifty-eight individuals from isolation; twenty from Shelby County, twenty-one from Spencer County, six from Trimble County, and eleven from Henry County monitored their symptoms and complied with a self-isolation agreement with the Health Department.
